Initial Training Requirements ALL training must be verified by ORO
Within 10 days of hire: An orientation within the first 10 days of hire and before staff have unsupervised access to children. AND
Within 30 days of hire: ☐ Introduction to Child Care Health and Safety (ICCHS) AND ☐ Recognizing and Reporting Child Abuse and Neglect (RRCAN) within 30 days of hire and prior to having unsupervised access to children. AND ☐ If the center is licensed to care for infants: CCLD approved safe sleep training, within 30 days of hire and prior to having unsupervised access to infants AND ☐ Oregon Food Handler's certification within 30 days of hire for cooks, kitchen staff and any staff who serve meals from a communal source or put away leftovers, and who prepare bottles or serve food. AND
 Within 90 days of hire: Current certification in first aid and pediatric CPR within the first 90 days of employment. Online CPR training is only acceptable if it includes hands-on instruction. AND Foundations for Learning (CCLD approved Child Development Training) within 90 days of employment.
Required Program Management Training Hours
 □ A Director must provide verification to Oregon Registry Online (ORO) that they have obtained 10 hours of training in the core knowledge category of Program Management; OR □ The Director must obtain 10 hours within the first year of hire.

Note: A center's substitute director must meet teacher qualifications, understand the director's responsibilities, be familiar with the certification requirements, have access to all records, and be authorized and able to correct deficiencies.
